Review conflicts of interest

- World Cup Bid Package
 - Trustees to review draft and finalize no later than May 27

 - New Deadline: Tuesday, 13 June 19:00

- D&O Insurance
 - Andy to chair working group, Nicholas, Alex to be group members
- Canadian not-for-profit organisation
 - Brian to research if we can claim Canadian not-for-profit or unincorporated association
 - Brian did some research and did not find anything why the IQA would not be eligible.
 - However, legal advice should be sought.

- The issue will be diverted to the Constitutional Committee.

Committee Updates

Branding Committee

- Andy and Alex created a questionnaire on what NGBs think about changing the name of the sport.
 - So far, there is a small majority in favor of changing the name (10 responses so far).
 - However, it is unclear how the discussion will turn out in Congress

Constitution Requirements Committee

 A couple of core user stories were discussed, but there is no thorough documentation yet.

Congress

- Next Congress meeting will be the day after this meeting.
- This is the first Congress session the Trustees have been officially invited to.
- Alex and Andy have a special interest in joining the meeting for the branding committee part.

Quidditch Media

- The IQA has a early access agreement with the Quidditch Post and other outlets.
- The Quidditch Post released an article about the Annual Report. The article said something along the lines of "We analysed the report so that you don't have to read it".
 - This contradicts the goal of the IQA that the community actually reads the publications the IQA releases.
 - Also, the article came out only a few hours after the original report was published.
- It would be preferable if the official IQA communication would be published first.
