# Open Opportunities, Risks and Issues

- In the event that people search for information about IQA, they are likely to find either the old website (which we do not control) or Wikipedia ahead of our new website which can lead to an inaccurate or harmful view of IQA.
- The bid time for World Cup is becoming short which could lead to reducing the number of potential applicants.

- D&O Insurance:

- Membership Fees:
  - Vanessa (Finance Director) will be tasked to send out invoices for membership fees.
- Nicholas Oughtibridge as Chair to invite Department Heads (through the Executive Director) to report back to the Trustees regularly (typically quarterly).
