Incorporation Update

Luke says that our lawyer has sent off the necessary paperwork to Delaware by fax, and is expecting the incorporation certificate to be coming in the mail next week.

AGM Date

Luke says that we need to give at least four weeks notice of the meeting, and that we have polled NGBs as to their preferred date of the annual meeting.

Alex discusses whether we should defer this decision to congress. Andy discusses some of the pros and cons.

Luke suggests that we discuss it with our volunteers first and then work out whether we want to suggest the idea to congress.

Alex suggests that we provide some of the detail to congress at the meeting, even if we don't give them a deciding power.
