General Congress procedures

- For anything "official" such as votes, decisions, etc. a motion is necessary. The motion must be seconded by another NGB before it comes to a vote.
- Please use the chat in Discord to bring forward motions as it is easier to be precise if we have the motion in written form.

Roll Call

- Note: Austria was moved from Developing NGB to Full Member NGB within this meeting. The roll call still sees them as developing, but in the attendance list the change is already reflected.
- Present: AUS (2), BEL (1), CAN (2), DEU (2), ITA (2), NLD (1), NOR (1), POL (1), ESP (2), GBR (2), USA (3), IQA (1) → 12 NGBs with 20 votes
- Absent: ARG (1), CAT (1), MEX (1), TUR (2), FRA (1) \rightarrow 5 NGBs with 6 votes
- 12 full member NGBs with 20 votes are present.
- 5 full member NGBs with are 6 votes absent.
- 20/26 votes are present, the meeting is quorate.

Previous Minutes

Confirmation of Membership Changes

- AUT wrote a email to the IQA some time ago that they want to be a full member but they never got the reply
 - The fulfill the requirements for full membership.
- IQA President: Motion: To add Austria as a full Member NGB.
 - Seconded by NLD.
 - Vote:
 - Yes: IQA, AUS (2), DEU (2), USA (3), CAN (2), POL, BEL, GBR (2), NOR, NLD, ESP (2), ITA (2)
 - Motion passed with 20 Yes votes.
- This means that now AUT is a full member NGB and can vote for the remainder of the session. Updated Roll Call numbers:
 - o 13 full member NGBs with 21 votes are present.
 - o 5 full member NGBs with 6 are votes absent.
 - 21/27 votes are present, the meeting is quorate.

Clarification of Term Lengths

- The IQA Constitution states that Trustees are elected for a 2 year term, unless otherwise stated by Congress. The Board has suggested that instead of looking at calendar years, we consider the period between AGMs. Since our AGM hasn't consistently fallen on the same dates, this avoids the problem of Trustees still having term left while we're electing new Trustees, or Trustees expiring before they are replaced.
- **NLD**: Any safeguards against AGMs not happening, or AGMs not happening every year (but every other year)?
 - Potentially a second motion/resolution of Congress to hold AGMs every year in roughly the same time.
- **NLD**: Motion: Congress specifies that Trustees will be elected for the period between the end of the AGM in which they are elected until the end of the second AGM following. This motion will retro-actively apply to the current sitting trustees.
 - Seconded by CAN.
 - Vote:

- Yes: CAN (2), DEU (2), USA (3), GBR (2), NOR, AUS (2), ITA (2), ESP (2), IQA, POL, AUT, BEL, NLD
- Motion passed with 21 Yes votes.
- AUS: Motion: The IQA Congress shall have an Annual General Meeting every year at roughly the same time, but not later than 14 months after the previous Annual General Meeting.
 - Seconded by DEU.
 - Vote:
 - Yes: USA (3), CAN (2), NOR, AUT, NLD, AUS (2), DEU (2), IQA, ESP (2), ITA (2), POL, GBR (2), BEL
 - Motion passed with 21 Yes votes.

Election of Trustees

- The application documents have been sent around.
- The Trustees formed a subcommittee to interview the candidates and shared a report.
- The report and the recommendation by the subcommittee are discussed.
- Election results:
 - Austin Wallace: 9 votes
 - Maggie Burlington: 14 votesNicholas Oughtibridge: 15 votes
 - Denis Ssekyanzi: 3 votes
 - Christina Verdirame: 18 votes
 - The 2/3 threshold is 14 votes, because a total of 21 votes were cast.
 - Therefore Maggie Burlington, Nicholas Oughtibridge and Christina Verdirame are (re-)elected.

Financial Statement

- Vanessa Sliva presents some numbers and shares an income statement for European Games and a general IQA balance sheet.
- The numbers will soon be published in the annual report as well.
